Ernie Stokes indicated he is going to fight that figures should correctly reflect the financial status of the Society.

We are on a calendar year budget. If we change we can get into difficulty with the I.R.S. Our fiscal year is January to December.

Julius Wadekamper indicated that the transfer of Executive Secretary's materials to Wisconsin from Vermont may cost \$500.00. It was the general opinion of the Board that this cost may be a little lower.

Mrs. George Doak wondered where expenditures for Trophies and Insurance are charged to. Julius Wadekamper indicated these are charged to Committee expenditures.

Fred Hayes - With the new form for the Quarterly Bulletin - will we have enough?

Julius Wadekamper thought that we will have enough.

Ernie Stokes - We are down to 80 copies of "How To Grow Lilies." I think 500 copies are being printed new, but this is not official. Stokes will verify this and advise J.W., soon as possible, possibly in a week.

Ron Chiabotta - Revisions should be made when making new printing of "How To Grow Lilies." J. W. - We will find out about this.

Beracha: I would like to know, as a new member, are there any projected areas of bringing in income?

J. Wadekamper - Fred Hayes - Stationery and sale of rare bulbs.

Moved and seconded by Tom Beckett and John Rutledge that proposed budget be approved. Question: All in favor. Carried.

Second point of business:

Julius Wadekamper - We will have an expanded Quarterly Bulletin. Jane Birchfield has a lot of suggestions that can be implemented in the Quarterly Bulletin. Now our job is to satisfy our members. One of the ways to satisfy the members will be this expanded Quarterly Bulletin. Bob Haring would like to present it in a new format - new way of printing. In addition, there will be information on Int'l. Shows, Regional information, and a Reporter from each Region who should send info. to Bob Haring.

Bob Haring: This would be an expansion. What we are talking about now is a drastic expansion. We will have Robin excerpts, articles on culture of lilies, articles on lily varieties, judges' training info, committee reports and work of the committees, list of growers too.

J. Wadekamper suggested Ads. General consensus of opinion was that we may run into trouble with the I.R.S. J. W. will investigate further on this.

International news, etc., - these are the ways we wish to expand the Quarterly Bulletin.

Discussion:

John Rutledge: How many Regional Bulletins do we get? A few.
Would each Director of the Robins extract for the Q.B.?

Fred Hayes: I would like to hear Bob Haring's comments on this Quarterly Bulletin expansion. Does he need assistance in his work?

Bob Haring: You and I have talked about this and I will do the best I can. In general, we are trying to get younger people to do most of the jobs, but editing is my business and so I am familiar with it and I will do the best I can. This will depend on how the Regional reporters and Robin reporters will cooperate. I will depend on everyone to get the material on time to me.

Bea Doak: How about Question and Answer box?

Les Johnson: Yearbook - very small proportion of Regional members belong to NALS. How are we going to get the info. to the Regional Members?

J. W. - This expanded Quarterly Bulletin will answer the question.

Cocker: Rob Haring wants reports from Regionals to put in the Q.B. Some of the articles in the NALS Quarterly Bulletin can be included in the Yearbook.

Windus: Cost would still be under control. We are thinking of "offset" printing.

Question: Moved and seconded that this Board approve the expansion of the Quarterly Bulletin according to the ideas outlined and according to the ways Bob Haring wishes to expand it. Carried. Movers of motion: Stokes Thayer

Ron Chiabotta: How are Regional Reporters established? J. W. - We will take care of that.

Julius Wadekamper: I would like us to meet again either in December or January. Saturday noon, December 29th, 1973 or Saturday noon, January 12th, 1974, at Kingwood Center, Mansfield, Ohio. If we have more than 6 members present that would be sufficient. We would need a quorum.

Moved by Stokes, Board of Directors, seconded by Ron Chiabotta, That we meet Saturday noon, January 12, 1974, at Kingwood Center, Mansfield, Ohio.

Julius Wadekamper: Dr. Ray Allen has already extended us an invitation.

Ernie Stokes: Those of us flying in would need transportation from Mrs. Collings. We fly to Hopkins - Cleveland. Angie will have 2 cars.

Julius Wadekamper: In case 13 people cannot come, and the number falls below a quorum of 9, we would drop the meeting.

Any other business?

Fred Hayes: I would like to refer to what you mentioned of the dates of the Annual Meetings and when we got to 1977 we were thinking of possibly Saskatoon and wonder if it would not be a good gesture to write Dr. Magainess and invite them to join NALS.

Julius Wadekamper: Ron Chiabotta would take care of this under Growth and

am going to go after charitable foundations. I am trying to approach the problem the best way. We have received \$500.00 from the Millicent Foundation. One problem, of course, is salesmanship. My idea is to keep our Yearbook in its present form with the hard cover. My real dream is getting a few pictures, in color, for the Yearbook. If we cannot raise the money, then we can, naturally, not do these things.

Foundation people want to know, first of all, what is our aim. Promoting the genus lilium is not enough. We have to dig down deeper than that. We want to enrich our lives and other people's lives too.

One very prominent person, Jan de Graaf, came out with one point strongly.
"Play the International aspect of this thing." In order to obtain money in my efforts we need support to keep our foreign members going. I am here now
to try and impress on you that we keep impressing ourselves that this is an
International society. Regionals fill a social need for lots of people.
Prestige is what we need and what we must hold.

Question: Haring: Have we been able to obtain official list of Foundations?

J.W. - No, but we can get one. Library can probably help. If Hannum cannot get one. Haring will.

Bob Haring: I recommend that each Regional sponsor one foreign member. Official request to each Regional President.

Cliff Hannum: Doubting little desirable on the International. These Foundations are interested in all the "goody" things, - great big one is World Peace, Law Enforcement, Ecology. We must think then in terms that these relations between our Nations are a small but very effective means.

Julius Wadekamper: Suggested Cliff Hannum write a good article for the Q.B.

Bea Doak: Why don't we set up a fund, along with other funds, so that if individuals wanted to donate a membership for any foreign members - it can be done.

Joe Mattas indicated Wisconsin-Illinois Regional sponsors a foreign member.

Perhaps some regional groups would like to do that - sponsoring a foreign member.

Connie Thayer: This should go to the Regionals so the Regionals can get it to their members.

Windus:

Tell Fred Abbey that he wouldpay all 3 foreign members.

Haring: Same line Abbey has been doing. This will be handled by Betty Clifford.

Julius Wadekamper: Under the Special Grants we get, keep in mind that we would like to build a fund so that the NAIS would be able to send a judge to any region and we would pay his expenses. Several regions have requested judging schools, but people cannot bear expenses. If we had a fund, this would be nice to do. All contributions without strings attached are the best, but otherwise would not be good. If donor gives without strings attached this wuld go into General Funds.
