Dr. George O. Doak volunteered to secure information from a North Carolina Librarian on how to index these Q.B.s.

Moved by Edward A. McRae, of Oregon, That Charles K. Kroell, of Michigan, be a member of this Nominating Committee.

Mr. John H. Lundgren, of Glen Cove, N.Y., made a plea that all N.A.L.S. Members try and send more seed to the Seed Exchange in 1976.
